The First-Year University Student Population in the Maritimes

The MPHEC today released a report on the profile and experiences of first-year students who started their post-secondary education at a Maritime university during the 2018-2019 and 2021-2022 academic years. All Maritime universities offering a bachelor's degree participated in the Canadian University Survey Consortium 2019 and 2022 surveys of first-year students as part of a collaboration group. The results of these surveys offer valuable insight into students' demographic characteristics, academic and employment profile, reasons to attend university as well as their satisfaction with their first-year experience. Two additional reports prepared for the Commission compare the survey results of Maritime universities to other participating universities in the country.

International Students in Maritime Universities

The MPHEC today released a report on 10-year trends in international enrolments and credentials granted in Maritime universities. The number of students enrolling in the region's universities has more than doubled in the last decade. In 2020-2021, international enrolment accounted for 22% of Maritime university enrolment, compared to 11% ten years earlier.

Effective Immediately: Changes to the Program Assessment Process

The Maritime Provinces Higher Education Commission (MPHEC) has been working to improve its program assessment process based on feedback received from institutions. We are pleased to announce the following changes, intended to help streamline the process and facilitate a timely decision:

New graduate-level certificate and diploma programs no longer require external reviews prior to submission.

Program terminations no longer require a proposal to be submitted for assessment.

Universities now have a maximum allowable time to respond to comments from the system or questions through the Stage I or Stage II Assessment process.
