# Profile, Employment Outcomes, and **Retention of Maritime University Bachelor's Graduates**


## Education

## **Highlights**

- Four classes of Maritime university bachelor's graduates were surveyed two years after graduation. This report looks at the profile of education program graduates, their employment outcomes, and their retention in the Maritime region.
- The majority of graduates were women, originally from the Maritimes, with a median age at the time of the survey ranging between 26.9 and 27.8 years.
- The majority of Bachelor of Education programs in Maritime universities are post-baccalaureate degrees. The percentage of graduates who had completed another post-secondary credential before enrolling in their education program increased from 78% for the Class of 2012 to 88% for the Class of 2020, with a university degree being the most common credential completed.
- Excluding those not in the labour force, 93% to 97% of graduates were employed two years after graduation. Compared to the Class of 2012, a higher percentage of Class of 2020 graduates worked full-time (68% versus 83%) and held permanent positions (30% versus 38%). The median annual income (in constant 2022 dollars) decreased from \$59,900 for the Class of 2012 to \$55,800 for the Class of 2020.
- About nine out of ten employed graduates thought that their job was related to their program, that they were using the skills they learned during their program, and that their education had prepared them for the workforce (i.e., to a moderate, considerable, or great extent).
- The percentage of graduates employed in the "educational services" sector increased from 77% for the Class of 2012 to 90% for the Class of 2020. Additionally, 88% of Class of 2018 and Class of 2020 graduates were working in "professional occupations in educational services".
- Two years after graduation, 68% to 79% of all education graduates were still living in the Maritimes. For graduates originally from the Maritime provinces, the percentage who remained in the region increased from 81% for the Class of 2012 to 91% for the Class of 2020.



## **Profile of Education Graduates**



<u>Gender</u>: This variable is obtained from the universities' administrative data. Hence, it is possible that sometimes the only information available is "sex at birth" in which case it is used as a proxy for "gender." Also, some institutions include "non-binary person" in the "unknown gender" category which makes it impossible to publish data on the non-binary population.

<u>Region of Origin</u>: The primary region of residence in the 12 months before enrolling in the program.

<u>Previous education</u>: The highest credential completed by graduates before enrolling in their education program. Credentials are classified into the following categories: University degree (includes bachelor's, master's, PhD/doctorate, and professional health doctorate), University diploma/certificate, College diploma/certificate (includes private college or training school diploma/certificate, apprenticeship diploma/certificate, and CEGEP), Other (any other diploma or certificate).


